

# **TERMS & CONDITIONS**

### Terms and Conditions for Kerdos One on One Session

Overview:

Kerdos One on One Session is a personalized strategy training session offered under the Traders Bay brand. The session is designed to provide focused one-on-one training in trading strategies. Due to the personalized nature of the session, there may be a waiting list. These sessions can be held online or in person.

By enrolling in or making payment for the Kerdos One on One Session, you (the "Client") agree to the following Terms and Conditions.

#### 1. Session Duration and Fees

- Sessions typically last between 2 to 4 hours, depending on the client's comprehension level.
- In cases where the session extends beyond 4 hours, an additional fee of \$500 per hour will apply.
- Maximum session time is 6 hours in one day.
- Should a client desire a repeat session, a fee of 50% of the full price is payable.

## 2. Client Responsibility

- It is the client's responsibility to fully understand the service provided by reviewing all relevant information on the Traders Bay website and these Terms and Conditions.
- Traders Bay will not be held liable for any misunderstandings or lack of awareness on the client's part regarding the session's structure, fees, or nature.

## 3. Delivery and Compliance

- The client acknowledges that Traders Bay will deliver the session in a manner that has proven successful over time.
- By enrolling, the client agrees to comply with all methods, structures, and processes of the session delivery.
- Non-compliance may result in removal from the program without refund and potentially lead to legal action.

#### 4. Non-Disclosure Agreement (NDA)

- A Non-Disclosure Agreement (NDA) governs all Kerdos One on One Sessions.

- Any client found to be harassing, exploiting, or attempting to maliciously harm others will be removed without prior notice and may face legal charges.

# 7. Eligibility

- Kerdos One on One Sessions are not suitable for beginners. Clients are responsible for providing truthful information about their level of expertise.
- Traders Bay takes no responsibility for clients who misrepresent their experience level.

# 8. Bonus Terms and Conditions

- The following bonus offerings are subject to additional terms:
- 8.1 Live Account Funding
  - Funding is available only after meeting the following conditions:
    - The client must consistently demonstrate a sound understanding and implementation of the strategy for a period of 6 months.

- Clients must exhibit loyalty and a positive attitude and refer at least one new client to join Kerdos.
- 8.2 Devices
  - Devices will be provided based on availability of stock and are only accessible to clients based in South Africa.

# • 8.3 Accommodation

- Accommodation is provided on a case-by-case basis. Should 4-star hotels be fully booked, Traders Bay will make alternative arrangements ensuring safety and accessibility.
- Traders Bay is not responsible for any theft, damage, or injury that may occur during transit or the client's stay.

# 9. Screening & Waiting Period

- All new sign-ups will undergo an evaluation and screening process to ensure suitability for the program.
- This process may result in a waiting period, allowing for scheduling and assessment.
- Any client found to have signed up with malicious intent, including but not limited to crowdfunding, fronting, or other deceptive practices, will have their membership terminated without refund.

## 10. Session Structure & Delivery Adjustments

- Session delivery may be adjusted upon agreement based on the client's needs discovered through consultations. This ensures that each client receives the best possible value aligned with their learning capacity and requirements.
- In some cases, we may recommend a pre-Kerdos online session before the Kerdos Strategy training whether online or in person.
- A structured learning path may include:
- **Pre-Kerdos Online Session** To introduce core concepts and ease client anxiety.
- Kerdos Online Session Full immersion into strategy, precision trading, and mindset mastery.
- In-Person Training (Scheduled 4 Weeks Later) Hands-on execution reflection for deeper mastery.

This approach ensures clients receive maximum impact from their mentorship experience.

#### 11. Monthly Subscription Plan & Live Sessions

- Clients enrolled in the monthly subscription plan will receive approximately 2 live sessions per month.
- These sessions will include:
- Theory-based learning to reinforce key trading principles.

- $\checkmark$  Access to a tutor for guidance and feedback.
